## **Dental Council: Consultation on the draft informed consent practice standard**

The Council has reviewed its informed consent practice standards, and as a result has developed an updated draft practice standard. This will replace the existing practice standards, and apply to all oral health practitioners.

The [consultation document](#) highlights the key proposals. We are now seeking your feedback on the proposals and the draft informed consent practice standard. The Council values all feedback received during its consultation processes. The consultation process provides practitioners and others with an interest in this area with an opportunity to have their say. All feedback received informs the Council's view as it works towards a final decision.

In accordance with the Council's guidelines on consultation, we have invited comment from all practitioners, relevant associations and societies, the Ministry of Health, District Health Boards, educational institutions, and other organisations with an interest in this area.

The submission period closes by end of business on **5 February 2018**.

### **Submissions process**

All submissions received will be published on the Council's website shortly after receipt, and will remain there as a public document. For submissions made by individuals, only your name and profession, if you are a registered health practitioner, will be published on the Council's website. All contact details will be removed from your submission.
