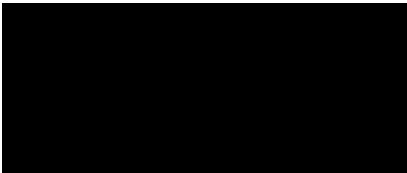

As a New Zealand graduate, we would have spent at least 4 years learning and adapting to the dental system in NZ, learning specifically about providing care in a way that is compatible and competent to NZ. I believe 6 months is not enough time.

For example, a NZ trained graduate requires at least 2 years of supervised practice AND competency assessment among other requirements to gain full registration in Singapore. I think we should adapt a similar model.
