In the Republic of Korea, approximately 700 to 800 new dentists enter the market each year. Although dental curricula are regulated by the government, while preparing for the NZDREX through the National Dental Examination Board of Canada (NDEB) Equivalency Process, I realised that the dental education I received in Korea contained many shortcomings and was often very superficial. To be direct, I believe that most Korean dental schools would fall short of the standards required by the DCNZ, because I have personally experienced this gap. Through preparing for the NZDREX, my professional competence as a dentist has improved significantly, and I have learned many things that were never properly taught in my dental education in Korea.

The dental profession in Korea is extremely competitive. Core principles that are highly valued in New Zealand – such as professionalism, health promotion, communication and collaboration, patient-centred care, and practice and information management – are largely neglected in Korea.

For example, implant treatment is heavily commercialised. Prices are widely advertised on social media platforms like Facebook, Instagram, and YouTube, with many dentists openly promoting their clinics online. Over-diagnosis and overtreatment have become common practice.

While Korea does have a licensing authority, it oversees all healthcare professions nationwide, which means dental regulation and monitoring are relatively weak. Given this context, it is deeply concerning to think that a dentist from Korea could be granted registration in New Zealand after only one year of supervised practice, without going through the NZDREX process.

I personally spent seven years preparing for the NZDREX, and through that process, I gained the knowledge, skills, and professional values necessary to meet New Zealand's standards. As a practising dentist in New Zealand, I find the Comparable Health System pathway extremely concerning for the safety and trust of the New Zealand public. I sincerely urge the DCNZ to reconsider this pathway carefully.
