Oral Health Practitioners (Disciplinary Levy) Notice 2025

This notice is pursuant to sections 130-133 of the Health Practitioners Competence Assurance Act 2003 ("Act"), and administered by the Dental Council.

Notice

1. Title and commencement

- a. This notice may be cited as the Oral Health Practitioners (Disciplinary Levy) Notice 2025 and shall come into force on 20 October 2025.
- b. This notice is secondary legislation pursuant to the Legislation Act 2019.
- c. This notice stands alone and the notified levies are in addition to the fees and levies contained within the "Oral Health Practitioners (Fees) Notice 2025 (No. 1)" notice published in the <u>New Zealand Gazette</u>, 10 January 2025, <u>Notice No. 2025-sl185</u> which remains in force.
- d. This notice is published on the Dental Council website www.dcnz.org.nz/resources-and-publications/resources/gazette-notices.

2. Levies

The Dental Council imposes levies as specified in the attached schedule, which are payable by registrants of the professions listed in the schedule who hold an annual practising certificate on the date that this notice comes into force.

3. Tax

The fees are stated exclusive of Goods and Services Tax (GST). All levies are subject to the addition of GST at the applicable rate.
